EXECUTIVE SUMMARY

This consultation report describes the consultation processes undertaken to prepare the Environmental Impact Statement (EIS) for the Aquis Resort at The Great Barrier Reef Project (the Project) proposed at Yorkeys Knob. Throughout the process, approximately 2000 people contributed inputs through face-to-face meetings, reference and focus groups, technical advice, online feedback, social media and community feedback forms.

The community feedback forms generated 1979 responses, 91% of which supported the project going ahead, with 82% unconditionally supportive. Conditional support was most frequently given on the condition that the environment is cared for or that locals are employed in the project. A word frequency analysis, shown in the word cloud below, shows the key elements of the positive responses, indicating a sense of hope and enthusiasm for the project by uplifting a depressed Cairns economy. This is shown below as a 'word cloud':



Inputs received through the consultation process were collated in a centralised Issues Register and coded for analysis. Through this process, seven key themes emerged:

- Environment
- Community
- Economic
- Infrastructure

- Approval process
- Resources

Key issues within the Community theme were generally associated with the significant increase in population and visitor numbers that would result from the project:

- Rent and rates increases for local residents;
- Location and style of extra housing for increased population;
- Stress on human services, such as medical facilities, schools and police;
- Noise from increased air and land traffic;
- Noise from the water park;
- Changes in the character of the local lifestyle, population, landscape and built environment;
- · Effects of gambling in the community;
- Engagement with the local indigenous community;
- Local access to resources such as beaches, parks and creeks, and to the resort facilities; and
- Traffic concerns.

Key issues within the Economic theme focused on:

- The significant contribution the project will make to the local economy;
- Retaining the economic benefits within the region;
- Provision of jobs for local workers;
- Improvement of the tourism product offering and international standing of Cairns as a destination;
- Economic benefits of increased visitor numbers; and
- Possible duplication of attractions resulting in a 'milking' of the Cairns CBD.

Key issues within the Infrastructure theme generally focused on the ability of current hard infrastructure to manage the increased population and the size of the proposed development. These focused on:

- Exacerbating an already existing water supply problem in Cairns;
- Increased waste production and disposal;
- Sewerage management;
- The capacity of the airport to manage increased visitor numbers;
- Flood proofing the Yorkeys Knob road; and
- Provision of adequate roads, cycleways and public transport options.



Key issues within the environment theme were:

- Protecting the ecosystem, habitat, flora and fauna, water quality and particularly the Great Barrier Reef;
- · Effectively managing cyclones and flooding; and
- Managing pollution issues fuel, runoff, acid sulphate soils, pesticides, litter.

Key issues within the Project theme focused on:

- The lack of appropriate context and scale of the existing proposal within the landscape, community and existing built environment;
- Provision of car parking; and
- Interest in ancillary sporting, recreation and conservation facilities.

Key issues within the Approval process theme focused on:

- A desire of the community and interest groups to be engaged by both the Proponent and government agencies;
- A need for a robust assessment process; and
- Fast tracking through the approval system (both positive and negative aspects).

Key issues within the Resources theme focused on:

- the capability of the region to respond to the demands of the project in terms of human resources, skills, and raw & manufactured materials; and
- the capacity of the local government to strategically respond to planning issues.

The Proponent is committed to ongoing public consultation throughout the notification of the EIS and will continue to engage with the community and stakeholders throughout construction and operation of the project.



1.0 INTRODUCTION

In August 2013, the Office of the Coordinator General issued Terms of Reference (ToR) for the preparation of an Environmental Impact Statement (EIS) relating to the Aquis Resort at the Great Barrier Reef proposal. Section 3.6-3.8 of the EIS ToR requires the following:

- an appropriate public consultation program with Local, State and Commonwealth government agencies, and potentially affected local communities;
- a description of the consultation that has taken place and how the responses from the community and agencies have been incorporated into the design and outcomes of the project; and
- a public consultation report detailing how the public consultation plan was implemented, and the results.

In accordance with these requirements, this consultation report details the consultation methodology, results, and a summary of issues from the consultation process cross-referenced to the relevant sections of the EIS where the issues are addressed.

2.0 CONSULTATION APPROACH

The consultation approach for the Aquis Resort at the Great Barrier Reef EIS was developed through a Community Consultation and Stakeholder Engagement Plan.

2.1 Community Consultation and Stakeholder Engagement Plan

A comprehensive Community Consultation and Stakeholder Engagement Plan (The Plan) was formulated by Flanagan Consulting Group (**Appendix A**).

The key objectives of The Plan were to:

- inform, consult and involve stakeholders and interested community members about the project and its likely impacts and benefits;
- solicit aspirations / concerns / local knowledge, for use in preparing the Social Impact Assessment (SIA);
- engage with expertise within and outside government agencies to assist with project development and refinement;
- establish two-way communication about the project;
- minimise the amount of misinformation that may circulate about the project;
- identify potential social impacts and develop strategies and measures to mitigate potential negative social impacts; and
- identify social benefits and opportunities that the Project presents to the local and regional community.

The key strategies to achieve these objectives were to:

- identify those with a stake and interest in the project;
- make information about the development broadly available and easily accessible;
- create multiple pathways to access information and to receive feedback;
- disseminate targeted information to relevant stakeholders;
- respond through an iterative process to community aspirations and concerns,
 either through project design modifications or provision of further information; and
- ensure information is accurate and consistent.



2.2 Consultation Delivery Teams

To assist with the timely and effective consultation and engagement for the preparation of the EIS, stakeholders were engaged in two ways. Identified stakeholders were engaged by the EIS team as community or organisational representatives or as experts in their field. A separate Community Engagement Team was engaged by the Proponent to educate, inform and engage with the wider public on the proposal. The structure of the two teams is detailed below in 2.2.1 and 2.2.2.

The Community Engagement Team provided information, education and consultation as inputs into the preparation of the EIS. They prepared the public information and presentation of material for the Project on behalf of the client. 3.0 CONSULTATION METHODOLOGY

The methods used in the consultation developed beyond the specifications of the Plan as interest in the project gained momentum throughout the consultation period. It is acknowledged that consultation and engagement involves a two-way exchange of information. This section describes the consultation methods used to engage the community, government agencies and experts in the preparation of the EIS, and the process through which it was analysed.

3.1 Summary of consultation and engagement methods

Throughout the project records were kept of information generated by the Proponent, Stakeholder Engagement Team and Community Engagement Team, as well as information generated from media articles, social media, and community feedback through identified stakeholder engagement and wider public feedback. Table 3.1 below shows a summary of consultation and engagement strategies undertaken throughout the EIS formulation.

3.2 Issues Register

The engagement methods detailed in Table 3.1 resulted in a significant volume of information collected on issues associated with the development. Other issues regarding the development were also highlighted through media reports and feedback on non-project related websites (such as the web forum conducted by the local radio station).

Each issue or response was logged on a master spreadsheet, cross-referenced with its source data, and coded according to key issues and concerns as they emerged. After categorisation and synthesis, these issues contributed to the Social Impact Assessment process, and were reported to the design or communications team for design refinement and/or impact mitigation. The Issues Register forms the basis of the results reported in this report, an excerpt of which can be viewed in **Appendix C**.

3.3 Stakeholder engagement methods

Whilst the methods of the Community Engagement Team were aimed at broadly engaging the wider public, the Stakeholder Engagement Team undertook a targeted engagement program in accordance with the Community Consultation and Stakeholder Engagement Plan. This included the Community Reference Group and the Focus Group stakeholder consultation processes. Contact with stakeholders throughout this process was recorded in a central Engagement Register.

3.3.1 Community Reference Group (CRG)

This group was formulated to comprise a balanced representation of community interests for ongoing consultation and to gauge community feel and issues as they arose. It was consciously constructed to include established leaders in the community from business, community and environmental sectors.

Members of the CRG were selected based on their ability to:

- represent the broad views of the community and the area of interest they represent
- actively participate in the CRG, attend the workshop and meetings in the timeframe notified;
- provide information to the Group about their area of interest or expertise
- take information back to members of the community; and

 work in a cooperative and productive manner with respect for others views and opinions.

Four representatives from each of the three sectors were invited to attend. If an invitee was unavailable, another representative from that sector was invited until four acceptances were secured from each group. The nature of community consultation however resulted in the slight expansion of one group (community). Because this was the key way in which the community was represented (business and environment both had specific focus groups) this expansion was considered acceptable by the Stakeholder Engagement Team.

Three meetings were held with the CRG on the following dates:

- 13th August 2013
- 22nd August 2013
- 29th August 2013

The first meeting with the CRG was a full-day engagement held on the comprising of a two-hour briefing, question and answer time, breakout discussion groups in the key areas of interest, and finally a facilitated discussion with the whole group. Subsequent meetings went for two hours, comprising updates on the project development and answers to questions raised in previous meetings, followed by further facilitated discussion. Records of Meeting containing key issues raised from each meeting is **Appendix B.5**. Issues raised were included in the Issues Register for further analysis.

The purpose of the CRG was to:

- act as a sounding board for the EIS Team through the identification of community issues and any concerns. It was not a decision making group;
- provide an opportunity for community involvement in the Project;
- accurately relay information from the group to the community so that the community is well informed about the Project;
- value add to the concept and design of the Project early in the assessment process;
 and
- focus on key issues associated with the overall Project, not individual interests, such as property access or compensation;.

The role of the CRG was to:

- confirm the social values of the community in relation to the Project;
- assist in the identification of potential impact and mitigations measures;
- assist in the identification of positive opportunities and benefits of the Project;
- suggest alternatives or solutions to potential impacts;
- provide the EIS team with the best available local knowledge to value add to the concept and design of the Project; and
- accurately relay information back to the community.

Constraints to the CRG were:

- it was not a decision making body;
- no one person was leader or spokesperson for the Group;
- there was a deadline and timeframe for their inputs to this phase of the Project;
- members did not represent every interest group and body in the Cairns region;
 and
- differences existed in the level of expertise and knowledge of members in the group.

The Proponent is committed to ongoing engagement with the CRG after the EIS has been prepared and submitted. This will occur during the government's review of the EIS, the formal public notification period and beyond (construction and operation).

3.3.2 Sector based Focus Groups

Sector based Focus Groups were formulated to engage identified groups with a specific stake in the project. These groups were identified by the Stakeholder Engagement Team as:

- Business
- Tourism
- Environment
- Emergency Services

Representatives from the CRG were also invited to attend the focus groups specific to their areas of interest. Like the CRG, the focus groups were consciously constructed to include already established leaders in the community from business, tourism, environment and emergency management sectors.



Similar to that of the CRG, Focus Group members were selected based on their ability to:

- represent the special interest area from the Cairns or regional area;
- attend the workshop in the timeframe notified;
- actively represent their area of interest or expertise;
- take information back to members of the community; and
- work in a cooperative and productive manner with respect for others views and opinions.

Whilst the CRG had a limit on numbers to ensure balanced discussion, Focus Groups did not have these limits, although to ensure productivity in discussion and smooth facilitation, a maximum of 12 members was considered reasonable. Recruitment was based on the snowball method through asking CRG members and other key leaders in the community in that area who they considered to be essential inclusions. Through this method, approximately 15 invitations were issued per focus group. With the exception of tourism (5 attendees), all focus groups had 7-8 attendees. Whilst the Stakeholder Consultation Team considered that the tourism group was slightly small, it was recognised that key decision makers from the industry were participating so were representative of the issues.

Focus Group meetings were held on the following dates:

- Business issues focus group 22nd August 2013
- Tourism issues focus group 23rd August 2013
- Environmental issues focus group 27th August 2013
- Emergency Services issues focus group 2nd September 2013

Focus Group meetings were three hours long and comprised of a half hour briefing session, followed by facilitated discussion. Records of Meeting containing key issues raised from each meeting are in **Appendix B.6**. Issues raised were included in the Issues Register for further analysis, represented in the Schedule of Comments in Section 5.

The purpose of the focus groups was to:

- communicate directly with stakeholders, providing them with accurate Project information in relation to their area of interest;
- minimise the amount of misinformation that may circulate about the Project;
- provide a forum for the EIS Team to listen and obtain feedback from these stakeholder groups about the Project in a quick and efficient manner;
- provide an opportunity for special interest groups to raise issues, concerns and ask questions about the Project in a proactive and respectful manner; and
- establish two-way relationship with stakeholders about the Project.

Constraints to the Focus Groups were:

- it was not a decision making body;
- no one person was leader or spokesperson for the Group;
- there was a deadline and timeframe for their inputs to this phase of the Project;
- members did not represent every interest group and body in the Cairns region;
- differences existed in the level of expertise and knowledge of members in the group.

3.3.3 One-On-One Engagement (targeted)

Throughout the EIS consultation process, a series of targeted one-on-one meetings were held with organisations identified by the Stakeholder Engagement Team as being potentially impacted, or having a specific interest in or influence on the project. Meetings commenced with an overview of the project by the Stakeholder Engagement Team and included a briefing on the existing environment, clarification of perceived impacts eg loss of cane producing land, airport safety and operations, proposed golf course competition and discussion regarding potential management strategies and key issues. Issues raised were considered in the project refinement, technical reports and social impact assessment of the Project.

Targeted one-on-one meetings took place with the following organisations:

The Yirrgandji Gurabana Aboriginal Corporation lodged a submission with the proponent outlining their environmental and social connections to the area. A copy of the submission can be viewed in **Appendix B.7.** Ongoing consultation with Indigenous Parties and the broader Indigenous community of Cairns will occur through the formal Cultural Heritage Management Plan Process, already underway as part of the EIS process, and during the formal public notification of the EIS.



3.3.4 One-on-one Engagement (technical)

To assist with the preparation of the EIS, a number of one-on-one meetings with state agencies, Cairns regional Council and technical advisors were held to gather relevant information and data for the Project and to negotiate technical aspects of infrastructure and design concepts. As with the targeted engagement, meetings commenced with an overview of the project by the Stakeholder Engagement Team and included a briefing on the project and discussion regarding potential management strategies and key issues. These technical issues were not recorded in the Issues Register, as they formed part of the data collection process at a technical level.

3.3.5 Community Feedback Forms

A key aspect of the community engagement strategy was the community feedback forms available for the wider public to complete in the shopfronts opened by the Proponent in Cairns Central Shopping Centre and Yorkeys Knob Shopping Centre. These forms were developed to gauge community feel for the proposal and were analysed through the central Issues Register. A copy of the feedback form can be viewed in **Appendix B.2**.



4.0 COMMUNITY FEEDBACK FORMS

The shopfronts continue to operate past the completion of this report and feedback forms will continue to be completed and analysed, however between 5th August and 9th September 2013, 1979 feedback forms had been received through the shopfronts. The quantitative nature of the community feedback forms has enabled a statistical analysis of the responses.

4.1 Demographic Profile of Respondents

Respondents to the Community Feedback Forms were not directly reprensentative of the Cairns LGA population (ABS 2011 Census), with some significant skews towards males (58% of responses compared with 50% in the Cairns LGA) and people in the 40-69 age bracket, specifically the 50-59 bracket, which represented over 25% of all responses (compared with 13.2% in the Cairns LGA). Charts 6.1 and 6.2 below show the age/sex distribution of respondents to the Feedback Forms.





Chart 4.1 Age distribution of respondents - Community Feedback Forms.




Chart 4.2 Gender distribution of respondents – Community Feedback Forms.



As expected, Yorkeys Knob residents were heavily represented in the Community Feedback Form respondents. Although not all respondents completed the suburb of residence section, 31% of all respondents identified themselves as residents of the Cairns Northern Beaches, and more than 11% were from Yorkeys Knob. Chart 6.3 below shows the distribution of Northern Beaches responses.

Given the large number of suburbs identified in the Feedback forms, it is difficult to represent them here, although further analysis is available.

In terms of communication, it is clear that most people filling in the forms heard about the project through the newspaper and television (note responses were not mutually exclusive). Chart 6.4 below shows where people heard about the Aquis project.




Chart 4.4 Information sources about the project – Community Feedback Forms.

4.2 Nature of responses

Although the nature of responses in the Community Feedback Forms were wide and varied, a simplistic assessment of the general feel of the community for the project was undertaken through coding the responses as 'positive', 'negative', 'conditional positive' (such as "as long as the environment isn't damaged, we think it is a great idea"), and 'technical question' (such as "how high will the buildings be?"). Chart 6.5 shows how the responses were distributed according to this.



Chart 4.5 General feel of community responses – Community Feedback Forms. (n=1979)





Chart 6.5 shows that the general feel of the community responses is significantly positive, and if the conditionally positive responses are also considered, 91% of respondents support the project going ahead. This was less pronounced in Yorkeys Knob, where 71% of respondents were positive, and 83% supporting the project going ahead. Chart 6.6 shows the distribution of Yorkeys Knob responses.

Chart 4.6 General feel of Yorkeys Knob community responses – Community Feedback Forms. (n=233)




Analysis of feedback forms received through the Yorkeys Knob shopfront in the first week of operation shows that 27% resided in Yorkeys Knob suburb. Of these, 68% were



positive and 80% supported the project going ahead. Chart 6.7 shows the nature of the Yorkeys Knob resident responses through the Yorkeys Knob shopfront (n=66).

The most significant difference between these responses and those of the wider community was the specific technical questions asked. Examples of the technical questions raised in these responses particularly relate to flooding and roads:

"Concerned about traffic congestion and possible delays by traffic to YK" (respondent CS1212).

"As I live at Yorkeys my main worry is a build up of water during flood time that will back up into township and flood houses that have not previously flooded" (respondent CS1212).

Because of the significant number of positive responses in the general public, a word frequency analysis was undertaken to further understand the nature of the positive responses, represented in Figure 4.1 below.

Figure 4.1 reflects the significant number of responses regarding the provision of local jobs and need for the economic situation to improve in the Far North Queensland Region. Examples of these responses are:

"This is a brilliant idea, Cairns needs this development. It couldn't come at a better time. Many thanks and good luck." (respondent CS121)

"Can't wait. Just what Cairns needs, to bring in more tourists and create more jobs". (respondent CS661)

Although there were fewer negative responses, a word frequency analysis was also undertaken to highlight key concerns of those not in favour of the development, shown in Figure 4.2 below.

5.0 SCHEDULE OF COMMENTS

The schedule of comments has been developed from the Issues Register, which compiled outcomes of consultation on the Aquis Resort at The Great Barrier Reef from multiple sources, as detailed in Section 3.2 of this report. To maintain accuracy in reporting these results, full comments or sections of meeting records were recorded and classified at multiple points, so may appear more than once in the summaries of comments. Issues identified in the consultation were classified into 7 key areas, in line with the categorisation of impacts in the EIS process. These areas are:

- 1. Environment;
- 2. Community;
- 3. Economic;
- 4. Infrastructure;
- 5. Project;
- 6. Approval process; and
- 7. Resources.

A comprehensive list of responses categorised into these key areas can be viewed in **Appendix D**. This section details the key issues identified within each category.

5.1 Environment

As mentioned in Section 6.1, environment has been a key issue for both objections to and conditional approval for the proposal. The majority of responses were concerned with generally protecting the environment, however specific issues arose as well. These have been classified through the Issues Register into six categories:

- Ecosystem;
- Hazards:
- Water quality;
- Soil;
- Flora/fauna; and
- People



Whilst the issues raised within this report identify community concerns regarding the environment arising from the consultation, actual and anticipated environmental impacts and mitigation strategies are addressed in the Environmental Impact Assessment.

5.1.1 Ecosystem

Protection for the ecosystem of the area, including the Great Barrier Reef, was considered to be of key importance to approval for the project. Table 5.1 below shows a selection of comments directly addressing general protection of the ecosystem.

5.1.2 Hazards

Two natural hazards were mentioned in the Issues Register relating to the development: Flooding and Cyclones. A number of concerns were raised about the location of the project being on a flood plain and close to the coast. In particular, Yorkeys Know residents were concerned that the development may worsen flooding for the township. Table 5.2 below shows a selection of comments directly addressing these hazards.

5.1.4 Soil

Acid Sulfate Soil, although identified as management issue by the EIS team, was only mentioned twice in the Issues Register. This may reflect a confidence that legislation will ensure management of Acid Sulfate issues. These comments can be viewed in **Appendix D**.



5.1.5 Flora and fauna

A number of concerns were raised regarding flora and fauna. Key among these were issues of habitat (particularly mangroves), birds, crocodiles, and fish. Concerns regarding crocodiles mostly focused on safety and management, whilst concerns with birds focused and fish focused on habitat provision. Table 5.4 below shows a selection of comments directly addressing flora and fauna.

5.2 Community

Concerns regarding the community and social impacts of the project were raised throughout the consultation process. Comments regarding the community tended to be less general in nature than the identified environmental issues, and focused around six categories:

- Housing
- Services
- Noise
- Character of the built environment
- People
- Local access

Whilst the issues raised within this report identify concerns regarding the community arising from the consultation, actual and anticipated social impacts and mitigation strategies are addressed in the Social Impact Assessment.



5.2.1 Housing

Issues raised regarding housing focused on a range of topics, particularly affordability of rent and rates and the location of extra housing to accommodate the workforce and consequent increase in population. Concerns were also expressed about the need for higher density styles of housing becoming prevalent, and 'thin end of the wedge' arguments about changing housing styles generally to a higher density 'city' style of living. 5.3 Economic

With approximately 20% of all responses to the community feedback forms identifying economic benefits to the region and improved job opportunities for locals, the economic impacts of the project were widely accepted to be significantly positive. Comments focused on three key areas:

- Regional economy;
- Jobs; and
- Tourism.

As with the environmental and social impacts, the issues raised within this section identify economic issues arising from the consultation. Actual and anticipated economic impacts and maximisation strategies are addressed in the Economic Impact Study.

5.3.1 Regional economy

Across all consultation processes, economic benefit was most regularly identified as a positive impact of the project. Many comments however focused on a concern with how much revenue will be retained in the region through the use of local products and services. Concerns were expressed about revenue being lost to large contractors based outside of the area, fly-in/fly-out (FIFO) or drive-in/drive-out (DIDO) workers, and 457 visas (these are addressed in the following section 6.2.3.2). Relatedly, also of concern was how to maximise the economic benefits in a lasting way for the region. Table 5.12 below shows a selection of comments directly addressing concerns regarding the regional economy.

Negative comments were concerned with the duplication of attractions, infrastructure and services, including the potential of detracting from the Cairns CBD, and significant competition for the current tourism product. 5.3.4 Infrastructure

Although raised less frequently than environment, community and economic issues, concerns regarding the how the project will influence the existing infrastructure was raised consistently throughout the consultation process. Key issues identified were:

- Water supply;
- Waste disposal;
- Sewerage; and
- Transport.

As with previous sections, the issues raised within this section identify infrastructure concerns arising from the consultation. Actual and anticipated infrastructure issues are addressed in the EIS.

5.3.5 Water supply

On Wednesday 11th September 2013, the front page of the Cairns Post was equally dedicated to a story about the Aquis project and a story on a proposed new dam to support water shortage issues in the region (see Appendix B.4 – Media reports). Issues raised through the consultation also made a connection between reported water shortages and the increased water consumption such a project and the associated population growth would bring. Table 5.15 below shows a selection of comments directly addressing concerns regarding water supply.

5.4 Project

The consultation also generated specific feedback regarding the concept and design of the project. Issues generally fell into two categories:

- Design; and
- Feedback.

As with previous sections, issues raised within this section identify project design and process concerns arising from the consultation. These formed inputs into the project refinement exercise as part of the EIS.

5.4.1 Design

Of primary concern to the stakeholders throughout the consultation was the context of the project – how the concept would fit with the landscape, community and existing built environment. A number of issues were raised around the need for tropical design and sympathy for the tropical environment. Also raised frequently was the scale and height of the project, proposed at 28 storeys high and with a footprint larger than the CBD of Cairns. Additional issues raised concerned car parking, suggestions for sports and cultural facilities, and green building techniques. Table 5.19 below shows a selection of comments directly addressing concerns regarding the project design.

5.5 Approval process

Throughout the consultation, issues were raised regarding the robustness of the government approval process and requests were made to be kept informed on the process and progress of the project.
